1. Addictions and Social Work

Compulsory Course taught at 5th semester students

The main purpose of the course is to acquire knowledge for understanding the detection and management of cases involving dependent family members (adolescents or parents).

The weekly course is divided into two equal parts (Theory and Clinical Practice - Clinical Examples and Role Playing).

Upon successful completion of the course, students will be able to:

Understand the contribution of social work to the prevention and treatment of cases involving addicted individuals.

Understand the concept and content of social work methods with addicted individuals (social work with individuals, groups, family and community).

Understand the different types of drugs (such as marijuana, cocaine, heroin) and types of addiction (alcohol, drugs, gambling and internet addiction).

They appreciate the strengths of family systems in resolving addiction among family members.

Dealing with abusive behavior of addicted individuals. Becoming aware of the prevention and promotion of psychosocial health of addicted individuals.

Becoming aware of intercultural approaches to addiction.

Apply appropriate clinical knowledge, skills, and techniques from diagnostic assessment to intervention and termination of social work with addicted users.

Use a model of inter-disciplinary and inter-agency collaboration.

Understand the goals, stages, and types of addiction recovery.

Understand the social, psychological, and biological factors that lead to substance abuse.

2. Social Work with Families

Compulsory Course, for students in 7th semester

This course aims to provide undergraduate students with knowledge of the understanding of the psychodynamics of the family within its social context and up-to-date knowledge of different theoretical approaches. By examining the role of the social worker, the stages, and techniques of social work with families, this course aims to enable students to implement diagnostic assessment of family dynamics, as well as strategies for family empowerment and different interventions in family crisis situations (e.g., domestic violence, divorce, family member's dependence on alcohol or psychotropic substances, family member's physical and/or mental health problem, disability, loss of a family member, family member's disability, family member's death, etc.).

Students are given real clinical cases of social work with families from the countless families that I have encountered in my clinical career, in which, of course, their identities are concealed for legitimate reasons.

The teaching is mainly based on the following books:

3. Domestic Violence and Abuse:

Optional Course, taught at 5th semester students

The main purpose of the course is the acquisition of knowledge and skills necessary for the detection, diagnosis and management of Domestic Violence and Abuse through a perspective of interdisciplinary cooperation with the goal of teaching a holistic approach to the social phenomenon. The theories of this timeless issue as well as its Historical Path are studied. The Legal and Psychosocial Context in our country and the International Practices are examined. Also, a review of relevant research studies and statistical data in our country and worldwide is carried out. Reference is made to the Organizations involved in the Prevention and Treatment of this Social Problem in Greece and Internationally. It is also explained how the Economic Crisis and the Psychosocial Effects of the Covid-19 Pandemic contributed to the rapid increase in incidents of domestic violence. Finally, this course aims at Practice through Documented а thorough Presentation of a Plurality of such cases from the beginning of their Detection, their Pediatric Psychiatric Assessment to their Final Outcome (removal or not from the family environment and management in the community context).

4. Introduction to Social Work

Compulsory Course taught at 2nd semester students (co-teaching)

This course aims to provide undergraduate students with knowledge of the history background of Social Work in Greece and at developed countries and it's up to date evolution. It starts with a definition of social work, reviews the history of the profession, and describes advocacy as a major aspect of social work. The advocacy practice and policy model is defined through examples and applications. It examines how social workers respond to human needs such as poverty and inequality; family and child welfare; health care and health challenges; physical, cognitive, and developmental challenges; mental health; substance use and addiction; helping older adults; and criminal justice. It also assesses the strengths of people and communities in support of possible advocacy strategies.

The teaching is mainly based on the following book:

5. Family Counselling in the Context of Social Work

Compulsory Course taught at 4th semester students

The main purpose of the course is to acquire knowledge and skills necessary for the application of counselling in social work with a special focus on family counselling. Counselling approaches in social work, types of counselling, interviewing in social work and counselling techniques are examined.

Issues regarding the application of counselling in multicultural families as well as in minority families are also analyzed. Teaching focuses on counselling children and adolescents as well as on sibling relationships. Examples of social work interventions that focus on the "here and now" are presented, discussed and analyzed, attempting to link theory

and practice in the context of applied social science of social work.

6. Social Work in Situations of Psychological Crises

Compulsory Course, taught at 6th semester

This course is based on several foreign and Greek bibliographical sources (M. PAYNE, K. KANEL, A. VERGETI, M. **DEMOPOULOU-**O'HAGAN, The syllabus begins with the LAGONIKA). presentation of the THEORETICAL APPROACHES to the crisis in general and the family in particular. It continues with the description of the main interventions in general and specifically in SOCIAL WORK. One chapter focuses on the management of cases of loss/mourning. Another chapter approaches the issue of dealing with cases of disability, chronic illness, traffic accidents and self-destructive behavior. It also discusses the management of crisis situations in sexuality issues (e.g. abortion, rape, homosexuality communication, working with LGBTI people and people with HIV/AIDS and their families). Reference is made to dealing with incidents of people in crisis due to addictive behavior (gambling, alcohol, drug use) and offending behavior (theft, violence, murder, substance use). In addition, the case management of cases in crisis situations due to dementia, Alzheimer and/or bedridden elderly people in hospital or in their homes is analyzed. Reference is made to crisis management in cases of natural disaster emergencies (e.g. earthquakes, floods, tornadoes, fires). In all courses, CASE STUDIES are given of incident management and techniques used by professional social workers.

7. Psychotherapeutic Approaches: Family Therapy

Compulsory Course, taught at 8th semester.

Teaching focuses on the presentation of the major first, second, and third generation family therapy models (communicative, intergenerational, structural, psychoanalytic, strategic, Milan systemic, solution-focused, and narrative), while studying clinical examples of each school of family therapy and providing students with the opportunity to become familiar with the family therapy techniques used in each model in the context of laboratory/clinical practice. Students are also given the opportunity to become familiar with the Synthetic Systemic Therapy Model in Greece

8. Inter-professional and Inter-disciplinary cooperation

Optional Course, 6th semester.

The teaching is based on the review of recent relevant research studies in different fields (health, typical and special education, services for physical and mental health problems) in institutions where staff work interdisciplinary and/or inter-agency for minors and adults (children's hospitals, child psychiatric clinics, general hospitals, psychiatric hospitals, institutions, shelters, ordinary schools and special schools, municipal social services, regional social services, prosecution and police authorities, juvenile courts, old people's homes, KAPI) in Greece and internationally. The syllabus refers to the analysis of relevant concepts, advantages and disadvantages of interdisciplinary cooperation, obstacles and techniques of effective cooperation, conflict resolution as well as reference to empirical and examples of good bad practice interdisciplinary and inter-administrative cooperation.

9. Graduate Seminars

Workshop, Optional Course, 8th semester.

Research study on a social issue or phenomenon related to Social Work. The assignment includes: search for relevant bibliographical sources (books and journals both in Greek and English), definition and description of a social phenomenon, design of a research methodology, determination of a research method, conducting a research study, data analysis, documented presentation of results and proposals. Drafting abstracts and teaching how to write them. Learning how to write publications in Greek and international journals. Explanation of the stages of organizing a conference or of the duties as a member of an organizing committee of a conference (Greek and international).

10. & 11. Placements of Students at Z' & H' Semester

Names of the Placements: (Childcare Centre for Girls Skagiopouleio, Ark of Love Home for the disabled, SOS Children's Villages, Smile of the Child Association, Magic Palace Children's Home, Agios Andreas General Hospital and Karamandaneio Children's Hospital, Alma Zois for Breast Cancer Cases, 1st & 2nd Special Primary School, SOPSY, KEDASY 20.

The students are taught in an interactive way how to manage complex cases through real cases from the workplace of the respondent, analysis of social films and videos, in vivo meetings with the Allocated Social Workers, they are also taught how to complete a social and medical history report and how to undertake referrals through relevant forms.

The students undertake interviews with beneficiaries in their Settings through role playing and finally they are taught techniques of parent counselling through vignettes of clinical examples.

12. Social Work with Families

The Unit provides services in all Clinics of the Hospital as well as in numerous Special Departments of the Hospital to children with:

Protection Framework which no longer have many beds available, cooperation with Associations that have volunteers to accompany the children to the hospital for a few hours, cooperation with a long list of services such as local social services to send to me the social report of the cases I have undertaken, cooperation with Child Protection Placements, submission of all documents for the admission of these children to a Child Placements).

 Dealing with dozens of cases of unaccompanied refugee minors.

b) Member of the Interdisciplinary Team of the Specialist Clinic for Autism Spectrum Developmental Disorders

(Child Psychiatrists, Psychologists, Social Worker, Occupational Therapist, Speech and Language Therapist).

It is aimed at children and adolescents up to 18 years of age and their parents who are referred with a possible diagnosis on the autism spectrum (e.g. autism, pervasive developmental disorders, asperger's syndrome).

The therapeutic team consists of mental health specialists trained (4-year training) in familysystemic psychotherapy. Sessions are monitored by the therapy team through a one-way mirror and there is supervision by an experienced therapist.
